

ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge that the registered child(ren)'s participation in Oakland's summer camp, is voluntary and carries with it the potential for death, serious injury and property loss. The risks include those caused by terrain, facilities, temperature, weather, equipment, vehicular traffic, actions of other people including participants, vendors, and producers of the event. I assume all the risks of me or the child(ren) participating or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released as well as services provided by person(s) or groups for which are employed to provide services in relation to this event.

I certify that the child(ren) registered are physically capable for participation in the event and have not been advised otherwise by a qualified medical person. I acknowledge that this Accident Waiver and Release of Liability form will be used by the event holders, sponsors, and organizers of the event in which I may participate, and that it will govern my and/or participating child(ren)'s actions and responsibilities at said events.

In consideration of participation, I hereby take action for myself, participating minors, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for participant(s)' death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter occur including my traveling to and from this event, the following entities or persons: Historic Oakland Foundation and all related affiliates; their directors, officers, employees, volunteers, representatives, and agents; and the event holders, event sponsors, and event volunteers; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by the negligence of releases or otherwise.

The Accident Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

The undersigned parent and natural guardian does hereby represent that he/she is, in fact, acting in such capacity and agrees to save and hold harmless and indemnify each and all of the parties referred to above from all liability, loss, cost, claim or damage whatsoever which may be imposed upon said parties because of any defect in or lack of such capacity to so act and release said parties on behalf of the minor and the parents or legal guardian.

Exemption Acknowledgement

I understand that Historic Oakland Foundation is a nonprofit organization that offers education programming for youth and adults. Historic Oakland Foundation youth programs are structured educational programs led by environmental educators, staff, and specialists. Historic Oakland Foundation programs are not childcare services so is not required to be licensed as a day care provider by the State of Georgia. In compliance with Georgia Department of Early Care and Learning (DECAL) requirements, Historic Oakland Foundation youth education programs has been approved for categories 591-1-1-.46(b)7, (EXMT-21056). Historic Oakland Foundation carries liability insurance coverage, as required by DECAL exemption rules. (EX-58151)
